### **Police Department Report for June 2021**

The month of June was another month of forward progress for the police department. We continue to work on visibility and relationships within the communities which we serve. Some of the high points are listed below.

1. St. Clair Township hired 2 part-time officers at the June meeting, Officers Gustkey and Constable. Officer Gustkey has completed his orientation and provided required documents. Officer Gustkey has been issued his MPOETC card showing his employment with this department. As of this writing, Officer Gustkey is ready to be scheduled for shifts.
2. Regarding Officer Constable: Dominic Constable was hired as a new graduate of the municipal police academy at IUP. Constable has not worked, previously, as a police officer. With that being said, the process with MPOETC (Municipal Police Officer's Education and Training Commission) is different. Said process involves making application with MPOETC for certification as a police officer. I have begun the application process for Constable and I am awaiting some needed documents from Constable so that said documents can be uploaded with the application. When the application is complete, MPOETC reviews the application and issues a card and certification number. The timing of this part of the process is outside of our control. This process can take days or weeks. This is of note because Constable cannot work (by himself) as a police officer until he has a certification number issued. A short training period has been

planned for Constable which will begin upon submission of a completed MPOETC application.

3. I have spent many hours and compiled numerous reports indicating that I worked on departmental policies. I have completed the "first run" through the policies. This first run was an extremely, time-consuming portion of the work. I will complete several more reviews and probable "edits" through the policies which should take less time. I have also completed the creation of several documents which police departments are required, by law, to issue during certain incidents. I have several more documents to create. I will also be completing a "procedures" section for this manual. My wish for the policy and procedure manual is that the manual provides clear direction and/or establishes a clear guide for the handling of police incidents in this department. The manual has the intended goal of standardizing police operations. Standardized and publicly-known policies and procedures will have a part in establishing or increasing the public trust.
4. Investigations continue into drug trafficking in our communities and surrounding communities. Both myself and Captain Kinkopf are currently rostered with the PA Office of Attorney General, Bureau of Narcotics Investigations, Task Force for this region. I have been in contact with a supervisory special agent for this region about the investigations. To advise, the funding for the Westmoreland County Drug Task Force comes from the PA OAG. We are working with the county task force as well.
5. Traffic update: vehicular speeds on the main roadways through the communities seem to have slowed significantly. I intend to maintain that focus but begin to observe some side roadways. As we receive complaints regarding these side roadways, I will ask for a time-frame of occurrence. This will be done to attempt to resolve the issue in a fashion making the most economical use of time. Some time ago, New Florence Borough provided this department with an ENRADD device (for timing vehicular speeds). I have this device tested in early June. The technician found that new battery packs are required for the device to function reliably. This is a good device to use for speed timing as it does not require the painting of lines on the roadway or a specific distance. The device cannot be used

during periods of rain or snow. I would estimate that the purchase of these battery packs (which have many uses outside of speed timing) would be less than \$200 and could be purchased from a "Walmart" or similar business. I am asking that the Township purchase 2 battery packs to get the ENRADD functional. Prior to purchase, please consult with me. I can provide you with an example of exactly what is needed.

6. I have obtained naloxone administration kits (3). One kit will be placed in each patrol vehicle. This project is complete.
7. The Dodge Durango was placed into service on June 9. A water pump issue occurred on June 24. It was returned on June 30. It will be designated as unit 492.
8. A departmental email system has been created. This will serve to streamline and solidify communications within the department. It will also provide a documented record of communications. When departments or officers fail in their mission, it is most often due to a failure of the communications system. Any work to strengthen communications within the department and also between the department and community is worthy of the effort. When our roster is complete, the departmental email addresses of officers will be provided to you.

In closing, I believe that the police department, again, made progress towards the goals of being a professional agency which is worthy of the public trust.

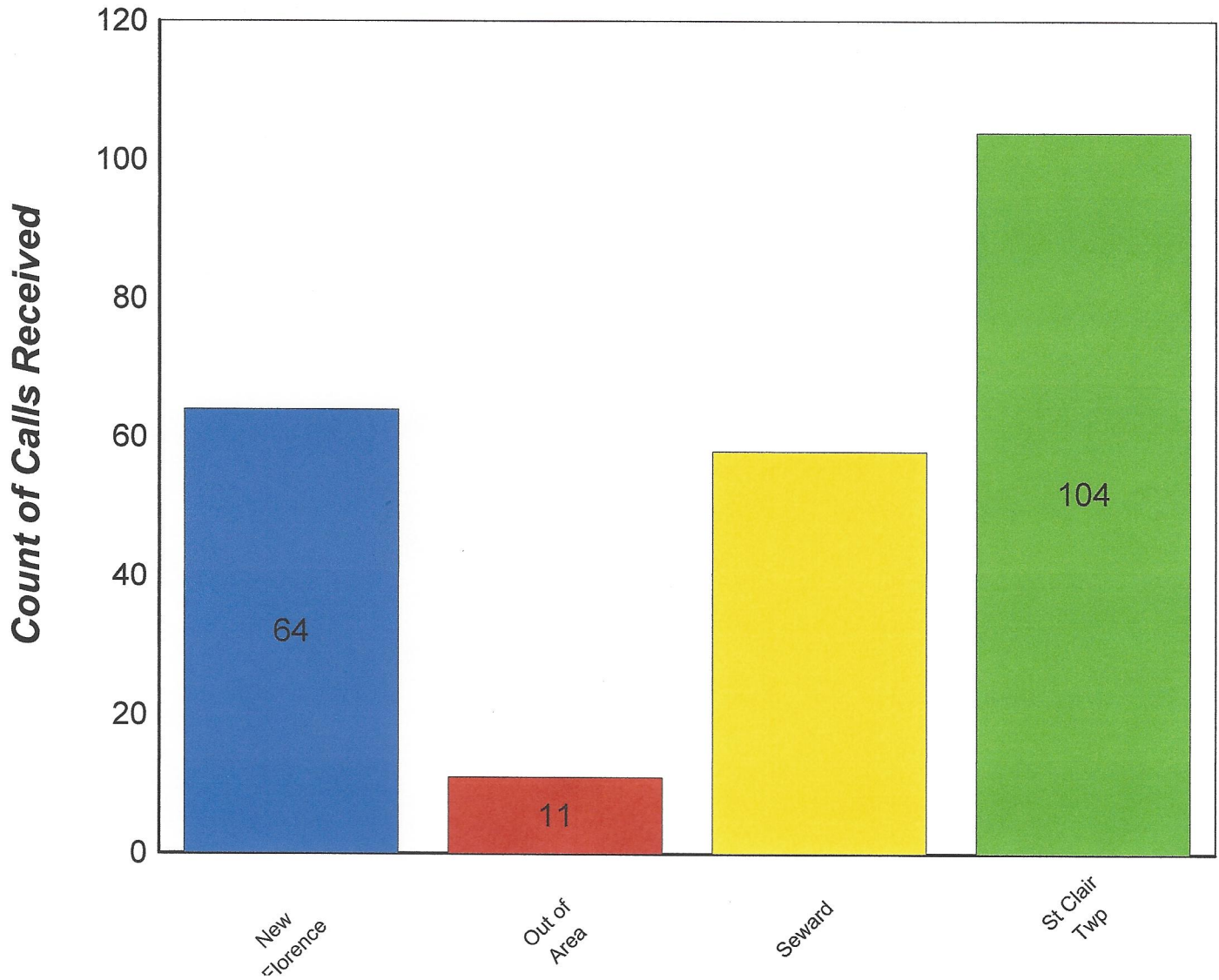

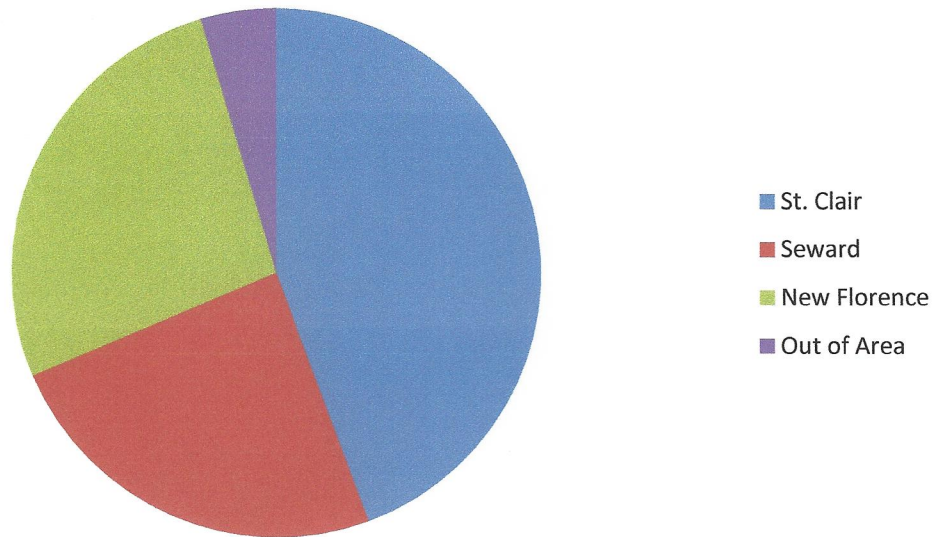
