Police Department Report for August 2021

The month of August 2021 was a month of continued accomplishment towards the vision for this department. We have continued to strive for greater involvement with the communities which we serve. We have continued developing policies, procedures, and accompanying documentation with the end-goal of presenting a professional police service to our citizens. This department will be transparent in operation so that the expectations are known.

Items of importance for August 2021 are as follows:

- 1. The policy/procedure work has continued. I have one set of policies complete but I have decided to do the policies in another format which is more professional in appearance and that matches all departmental documents. When complete, the department policies will be available to all in an "online" version. Also, any documents for public use will also be available online.
- 2. As a reminder, I do not intend to renew the license for the police reporting system which we currently use. I do intend to obtain a new reporting system (CNet) at the time which our current license expires. This will be an overall cost savings and will improve the functionality of our reporting system.
- 3. If it is time to reapply for a grant through the Ligonier Valley Endowment, I would like to obtain:
 - a. An in-car computer system with scanner and printer.
 - b. A dash camera for collection of traffic evidence, etc.
 - c. A digital camera for collection of crime-scene/evidentiary photographs.
- 4. We have been spending more time working on several, criminal investigations. With that being said, our number of reports may decrease to a degree.
- 5. I have begun developing a "Special Needs Program Registry". This is a proactive program designed to make emergency services aware of those in our communities that may have special needs so that reasonable preparedness and

accommodation can be made. This program is a voluntary program on behalf of residents. This program with gather demographic data from applicants. This program will also gather data regarding both physical and mental health issues. This information is best gathered before an incident so that the time spent on an incident is geared towards gathering incident-related information, not person-related information. It is aimed at solving problems in a more expeditious fashion. For example, if someone with some cognitive impairment becomes lost, we will already have their personal information and emergency contact information to make the process of a safe resolution more streamlined. With the streamlined approach, we can focus more on locating such person.

- 6. Looking ahead, I am considering the development of a program for November. November is Men's Health Awareness Month. This program could involve some short, community walks (weather dependent), some simple exercise activities at the local community centers, and some discussions of health issues.
- 7. The issue with the lightbar on the Dodge Charger (491) is on-going. The vehicle was taken to TeamForce and they could not replicate the problem. Shortly after the return of the vehicle, one of the lights came on and stayed on for a period. As instructed by TeamForce, I will attempt to obtain a video of the problem and provide it to them.
- 8. We are not yet averaging 104 hours per week worked by officers. The main factor for this month was officer illness. Further, we have had very limited or no availability from some part-time officers. When we can consistently meet the 104 hour/week requirement, I can begin establishing extra-duty programs which will put more officers in the areas which we cover at no additional cost to the municipalities.




