#### **Police Department Report for September 2021**

- 1. This past month has been a month of continued work with on-going projects (department policies) and planning for upcoming changes. One projected change will be the implementation of a different, police reporting system and or near the end of October. The new police reporting system will provide a cost savings and will provide greater functionality, including the ability to "electronically" file traffic citations if we possess the proper hardware. The appearance of the call logs which are provided with the monthly report will change due to the system change. This change will be very time-consuming as it occurs.
- 2. Beginning with the next monthly report, the fuel and mileage page will have a different appearance than the previous reports. I am moving this report over to a spreadsheet format. The report will look different however the report will continue to contain all of the information being provided currently.
- 3. With this month's report, a breakdown of traffic enforcement (warnings and citations) is included.
- 4. Hours worked by the police department remain short of the goal of 104 hours per week. Various factors have caused this to occur over the past month. Consistency is achieving 104 hours per week needs to occur so that certain programs can be initiated and staffing can be expanded (at times) beyond 104 hours per week and at no additional cost to the communities which we serve.
- 5. The Departmental Policy Manual is nearly complete and will be provided to the Township Supervisors for review. When the policy manual is approved, I believe that the manual should be available to the public for their review. Certain sections of the policy manual will not be "publicly available" to protect certain interests regarding security.
- 6. I am thankful that both New Florence Borough and Seward Borough are interested in renewing their police service contracts with St. Clair Township. During my first 7 months with this department, an effort was made to balance being visible in the

communities, providing solid responses to calls for service, and building a police department based on policy which is current and accepted. The administrative portion of this task is challenging and has been very, time-consuming. The renewal of the service contracts indicates to me that the communities are satisfied enough to provide another commitment. I will continue to work to satisfy or answer any concerns which our communities discuss with me.





#### **September 2021 Motor-Vehicle Accident Information**

For the month of September 2021, the police department responded to 3 reports of motor-vehicle accidents. The data sheets are included in this report.

Of the 3 motor-vehicle accidents reported, 2 occurred within St. Clair Township and 1 occurred within New Florence Borough.

For explanation, in Pennsylvania, police departments categorize motor-vehicle accidents as either "Reportable" or "Non-reportable". These terms come from Section 3746(a) of Title 75, Pennsylvania's Consolidated Statutes. In either instance, the police department does complete a report for the accident. Pennsylvania Publication 153 (Police Officers Crash Report Manual) provides further information into crash reporting by police. Title 75, Pa C.S., Chapter 37, Subchapter C (Accidents and Accident Reports) provides the current laws regarding accidents involving vehicles and the reporting requirements.

A "Reportable" accident is one in which one or more persons sustains injury or death or one in which a vehicle requires towing. Reportable accidents are reported by police departments using the PennDOT Crash Reporting System, an on-line system. By reporting in this fashion, PennDOT can gather data from crash reports and then use such data to determine trends and patterns to assist in guiding decision-making regarding roadway design, traffic-control devices, and speed limits to name a few.

A Non-Reportable accident is more commonly known as a "fender-bender". In this classification, no person involved has injury and neither vehicle requires towing due to damage. These are the most common reports for motor-vehicle accidents. The police department will respond, gather information about the accident, and complete a departmental report, not a PennDOT Crash Report.

#### **September 2021 Criminal Investigations**

As a reminder, The St. Clair Township Police Department does not release specific information, in the monthly report, regarding criminal investigations. This information is guarded to maintain the integrity of on-going investigations.

These criminal investigations are located within the departmental reporting system as "Incident Reports".

For September 2021, the department logged 7 total criminal investigations. The community breakdown is as follows:

A. St. Clair Township: 5

B. New Florence Borough: 2

C. Seward Borough: 0

Of the 7 criminal investigations, 5 were involving fraud or attempted fraud, 1 involved a theft, and 1 involved a criminal mischief. 1 criminal investigation, which is not listed within the 7, remains in the early stages of investigation as determinations are being made as to the involvement of another agency (or agencies) to assist in the investigation.

Of note is the fact that, in many instances, an investigation is not completed within a month or by the end of a month. Such investigations are "on-going". Police will continue to work on such investigations as information becomes available.
