Police Department Report for October 2021

1. October 2021 continued to be a month of "fraud/attempted fraud" incidents. The recent trend regarding fraud entails the involvement of the PA unemployment compensation system. These incidents involve electronic deposits to accounts, not checks being sent. Such deposits require tracking of the deposit which, in many cases, leads outside of this area, Commonwealth and Country. Those who find themselves victims of such crime or criminal attempts are encouraged to:
 - a. File a report with this department
 - b. File an online complaint with the PA Office of Attorney General (will have further investigative capabilities)
 - c. Obtain copies of their credit reports to determine the extent of identity theft.
2. Captain Kinkopf completed Crisis Intervention Training this month. The training in crisis intervention is valuable as it has shown to reduce the use of force by officers when dealing with a mental health crisis. The training was 40 hours in duration. De-escalation has been a focus of this training.
3. The department has began using a new, police reporting system at a cost savings of approximately \$400 per year. The new reporting system, cNET, provides a more efficient workflow and allows for increased functionality without increased spending. This would include the electronic filing of traffic citations. The setup and approval for electronic filing is pending action by the Administrative Office of Pennsylvania Courts. This specific process will take 3-4 months to complete.

4. The new reporting system will move the department from using the PA Uniform Crime Reporting system to report criminal incidents each month to using the PA National Incident-Based Reporting System (NIBRS) to accomplish the same task at a higher level of detail. Further, the move to NIBRS-based reporting will allow the department to apply for grants which are for NIBRS-only agencies. Many departments have yet to convert to NIBRS-based reporting. This is not automatic. The approval process is several months long and includes a testing process.
5. Regarding traffic enforcement, this department has taken a proactive stance. We strive to be as visible as possible to deter poor driving behavior, especially aggressive driving. We strive to perform stops when offenses do occur within our presence. We issue either warnings or traffic citations. When a traffic citation is issued, a defendant can either plead guilty or not guilty. Even if a defendant knows that he/she committed the act, they may plead not guilty (which seems to occur most of the time). A "not-guilty" plea results in a summary trial being scheduled with the magisterial district judge in Ligonier. Said hearing takes the officer out of the coverage areas for at least 1.5 hours. This department issues citations when the investigating officer believes that a citation is the proper course. This concept falls under "police discretion". The use of discretion is contained in the SCTPD Policy Manual which was provided to the St. Clair Township Supervisors for review.
6. The volume of reports is lower this month than on previous months. This is a direct result of a lower number of hours worked by officers in the department. Hopefully, this situation is resolved.
7. The department has yet to receive word on the grant request from the Ligonier Valley Endowment. The request was entered for funding to provide the department with an in-car computer system. This request was made in order to gain in several areas, including the ability to enter reports from the vehicle, the ability to file traffic citations electronically and from the field (reducing the need to drive to Ligonier to drop-off citations), and the ability to remain out in the communities, not in an office completing reports. A mobile computer will provide officers with the ability to obtain evidentiary photographs without using a mobile phone. The use of a personal, mobile phones to obtain evidentiary photographs is frowned upon in law enforcement.
8. As a reminder, this police department has no authority to resolve matters of civil law. On civil matters (for example: property line disputes), one must contact an

attorney for advice on how to proceed or file the matter privately with the magisterial district judge. Further, the police department does not enforce ordinances in St. Clair Township, New Florence Borough, or Seward Borough.

9. When police file a charge and it is logged with the Administrative Office of PA courts, the information (to a degree) is publicly available by locating the website for the Pennsylvania Unified Judicial System (via a search engine). Simply navigate the site and the information is available. The department has received some questions regarding whether or not charges were filed. This website will provide the answer. Your patience is appreciated when a charge is filed. In summary level violations (citations), the average time before a hearing is scheduled for the matter is 2-3 months. This department does not control the scheduling of hearings.
10. On October 27, 2021, I made a decision to, temporarily change the operation of the department due to an increase in the number of COVID-related deaths within our communities. The main portion of the change involves reduced, in-person contacts, handling many police requests by phone. This is similar to a plan that I was involved in previously, at the projected height of the pandemic. This was done to potentially avoid the spread of COVID (from officers to the community and from the community to officers). With a small number of personnel attempting to work 104 hours per week, we cannot afford to lose an officer to COVID or a COVID exposure and come close to meeting the hours requirement. If the intensity of COVID decreases in the coverage areas, we will resume normal operations.

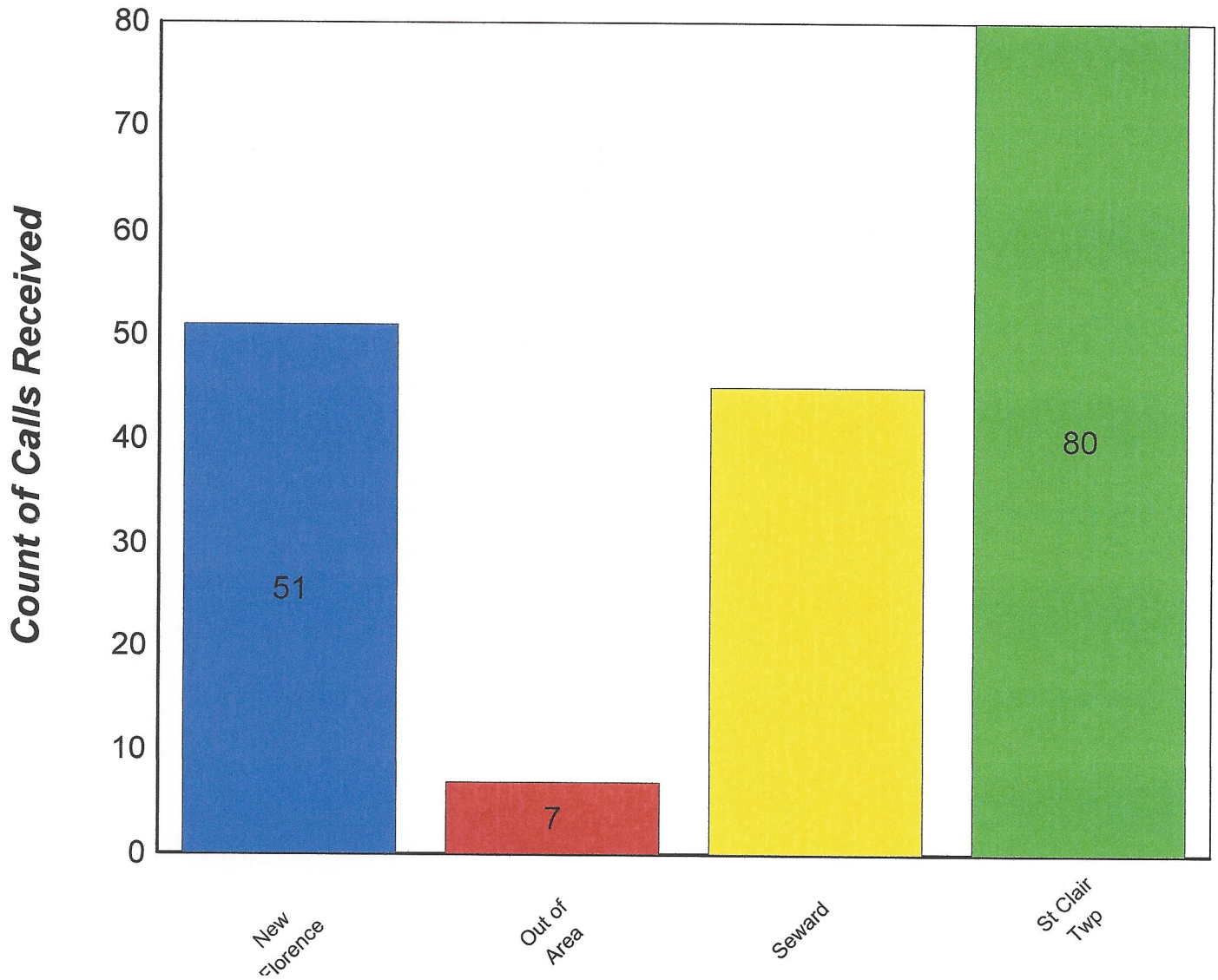

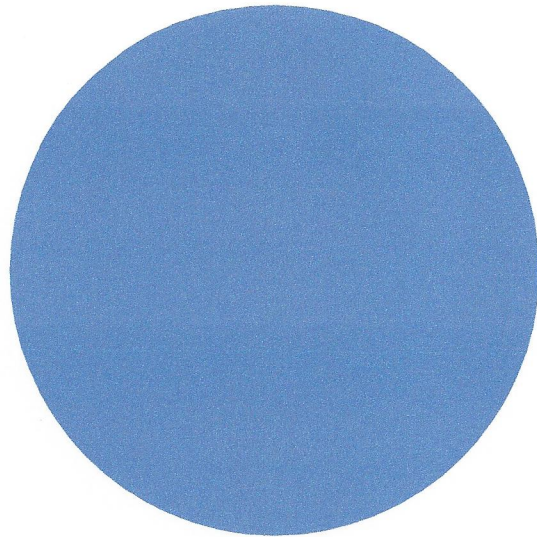

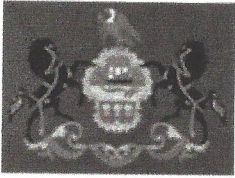


October 2021 Stops
