
Police Department Report for November 2021

1. The department continues to operate with additional caution during the on-going COVID-19 threat. The plan for decreased, personal contacts will continue. We will continue to be visible within our communities. We will make "in person" contacts as needed but we will operate with an abundance of caution.
2. Early this month, Captain Kinkopf provided his resignation to be effective November 18. I am thankful for the assistance which he provided, especially early on, with this department and the mission.
3. The new reporting system is in use. You will notice that the format has changed. Further, the new software also refers to routine police reports as "complaints". I ask for your patience as we work through this transition. I wish to provide you with as much, detailed information as possible without compromising investigations.
4. I had conversation with Supervisor Koch regarding the New Florence Borough "Jake Brake Ordinance". Some research will need to be completed prior to enforcement. Said research will encompass compliance with any Commonwealth or PennDOT regulations surrounding such an ordinance, formal training on "Jake Brakes", and a method to capture the evidence of "Jake Brake" usage. In summary, I do not wish to waste time issuing citations for this ordinance if we are unable to provide successful prosecution for the offense. I wish to be in complete compliance with any and all rules concerning said prosecution so that the drive to the District Judge's Office in Ligonier is not wasteful.
5. Regarding the on-going narcotics issues within the 3 communities, I attended a County Drug Task Force meeting in November. The PA Office of Attorney General, Bureau of Narcotics Investigation was also in attendance. Active investigations are occurring in our communities by these agencies, in cooperation with this department. I cannot provide much detail as it could compromise those investigations. I ask for your patience as this process occurs. The amount of time that this process takes before some result (an arrest) is seen can be frustrating for

communities. However, this process is necessary to ensure proper legal observances and proper investigative techniques. I also ask for your continued assistance by providing any information regarding suspicious activities within the communities.

6. Both Officer Kasterko and myself completed annual, firearms qualifications as required by the Municipal Police Officers Education and Training Commission.
7. I completed recertification as a state-certified EMT/Paramedic. I will continue to provide emergency assistance as needed, utilizing caution during the pandemic. I also completed certification as a certified personal trainer. I am considering development of a program to be launched in the spring/summer focusing on health. A healthy community is a happy community.
8. This department does not follow a "quota system" regarding traffic enforcement. We are committed to providing enforcement of traffic laws by completing vehicle stops when we observe violations of the PA Vehicle Code. The decision to issue a citation or provide a warning rests solely with the discretion of the officer. Generally, police officers know when a violator should receive a citation. Discretion is an important part of policing; without it, a police department becomes an occupying force. Furthermore, failing to allow officer discretion is not in alignment with modern, community-oriented policing models.
9. As the season turns to winter, I will be focusing on the administrative development of some departmental procedures (for example: evidence) and on required training. As a department, we will continue to be out in the community, but we will shift some focus as the number of persons outside decreases due to the weather.
10. The Township has advertised for the position vacated by Captain Kinkopf. I am unaware of a timeline to have another officer on staff.

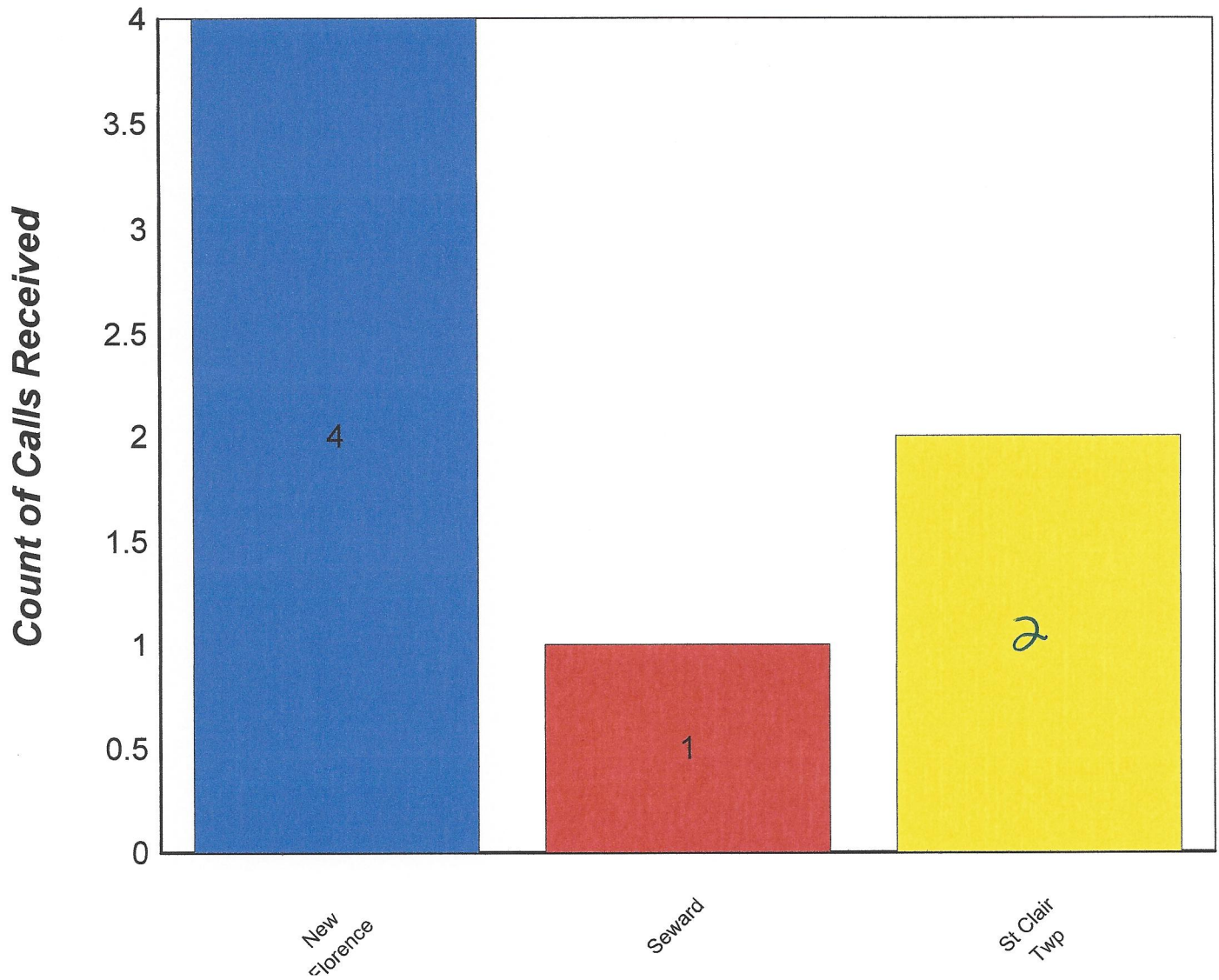


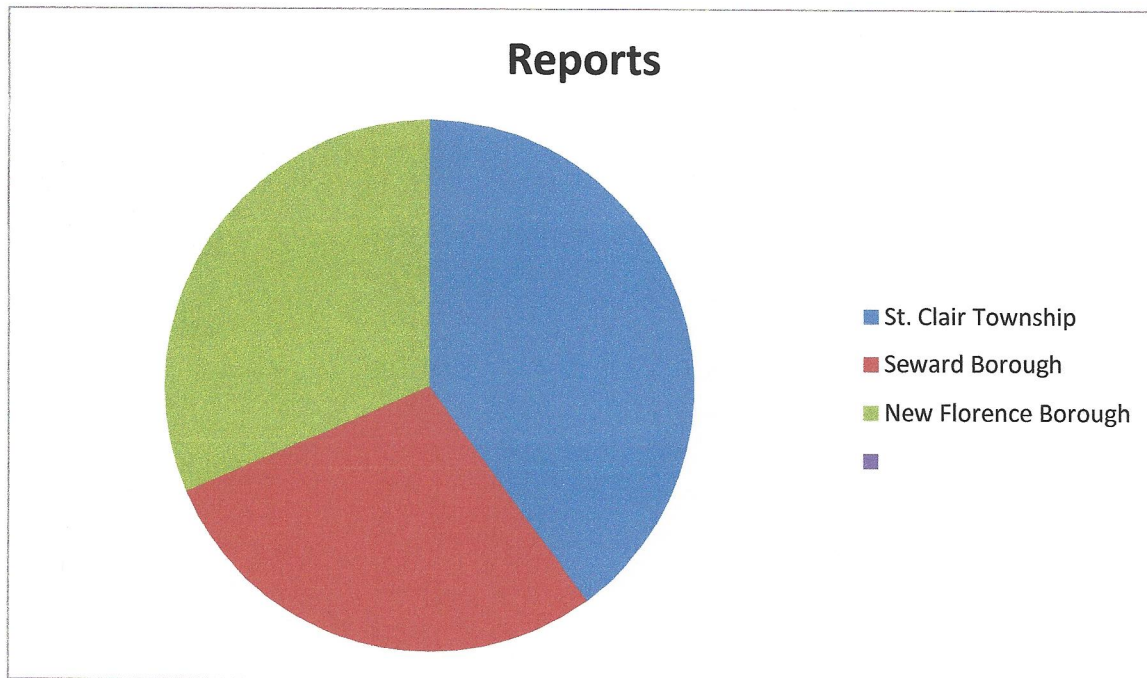
