BOROUGH OF NEW FLORENCE, WESTMORELAND COUNTY, PENNSYLVANIA – ORDINANCE NO. 24 OF 2008

AN ORDINANCE AMENDING ORDINANCE NO. 203, REPEALING SECTIONS 7, 9, AND 11 AND ADDING NEW SECTIONS 7, 9, AND 11.

NOW, THEREFORE, be it ordained and enacted by the authority of the Borough Council of New Florence, Westmoreland County, Pennsylvania, as follows:

- 1. Section 7 of the Borough of New Florence Ordinance No. 203 is hereby repealed.
- 2. Section 9 of the Borough of New Florence Ordinance No. 203 is hereby repealed.
- 3. Section 11 of the Borough of New Florence Ordinance No. 203 is hereby repealed.
- 4. The following sections are hereby added to Ordinance No. 203.
 - a. Section 7. Retrieval of Cats or Dogs. The owner of a cat or dog that has been seized for the first time may retrieve the cat or dog upon payment to the Borough of reasonable expenses incurred in seizing and retaining the cat or dog, including the cost of impounding the cat or dog in a kennel. The owner of a cat or dog that has been seized for the second or greater time may retrieve the cat or dog upon payment to the Borough of a \$15.00 penalty, plus any reasonable expenses incurred in seizing and retaining the cat or dog, including the cost of impounding the cat or dog in a kennel.
 - b. <u>Section 9.</u> <u>Penalty.</u> Any person who violates this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of not less than Fifty and 00/100 (\$50.00) Dollars nor more than One Hundred and 00/100 (\$100.00) Dollars, as well as reasonable fees for keeping the dog or cat in a kennel. All fines and costs shall be in addition to the amounts that are required in Section 7 of this Ordinance.
 - c. <u>Section 11.</u> <u>Cat Licenses.</u> Cat licenses may be purchased at the Borough Office, during regular office hours to be determined by Resolution, for the cost of Ten and 00/100 (\$10.00) Dollars for owners under the age of sixty (60) and Eight and 00/100 (\$8.00) Dollars for owners over the age of sixty (60). Said license will not be issued unless and until the owner of the cat can provide documented proof that the cat being licensed has received proper rabies shots. If any owner, regardless of age, can provide

documented proof that the cat being licensed has been spayed or neutered, the cost of the license will be reduced by twenty (20%) percent.

5.	Effective Date.	This Ordinance shall become effective immediately.
