

### **Police Department Report for May 2023**

1. This month shows a reduced number of reports in the system. This is due, in part, to Officer Marsh missing work due to injury. He has since returned to work. Further, some reports have not been entered (traffic monitoring, foot patrols, community policing, etc.) due to a focus on investigations, both on-going and new.
2. This month was busy with investigations and arrests as indicated by another page of this report. A search warrant was executed by Officer Marsh which resulted in an arrest for drug charges.
3. Criminal Investigator Goggin completed his Criminal History Certification. He is now permitted to access that database. This certification also allows him to access other databases which will expand his knowledge and further develop this department.
4. This department had a number of incidents involving loose dogs. We are capable of enforcing the provisions of the PA Dog Law. The best advice to our communities is to keep your dog on your property or leashed when off of the property. The potential results, if something bad occurs when not in adherence with law, can be financially-impactful.
5. This department encountered a rattlesnake in St. Clair Manor. This indicates that the snakes are beginning to move. The best advice that can be provided is to keep your properties cut. This reduces habitat for field mice, etc. which the snakes are looking for.
6. Criminal Investigator Goggin purchased a hand-held license plate/registration scanner. This device can be plugged into a mobile computer and, on a traffic stop, the required documents can be scanned. This scanning "auto-populates" the citation. This saves time on completing citations.
7. The Dodge Charger was involved in a collision with a deer. PSP conducted an investigation, to avoid any conflict of interest.

8. This department is clearing investigations at a very high rate by comparison to other, nearby departments. These clearances are by arrest of the offender. This high clearance rate is due to the time being placed on such investigations (gathering evidence, using technology, continuing education, and observation).

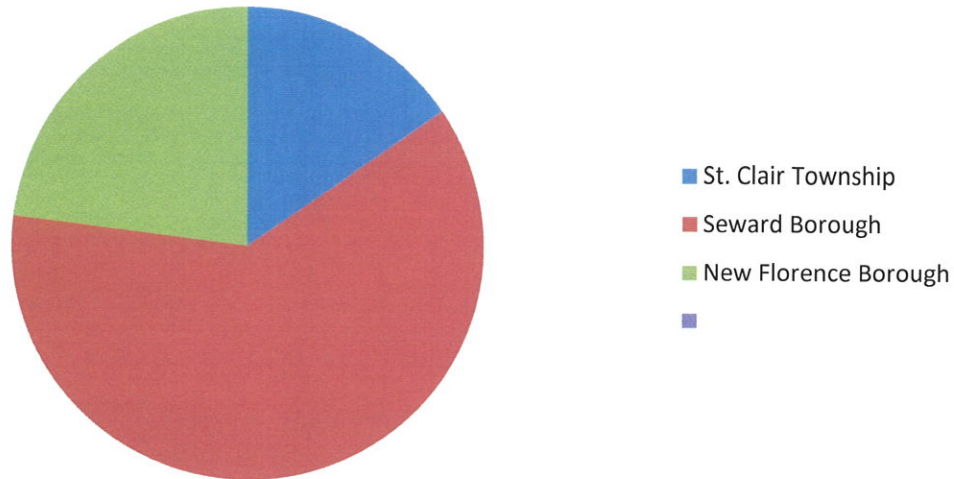

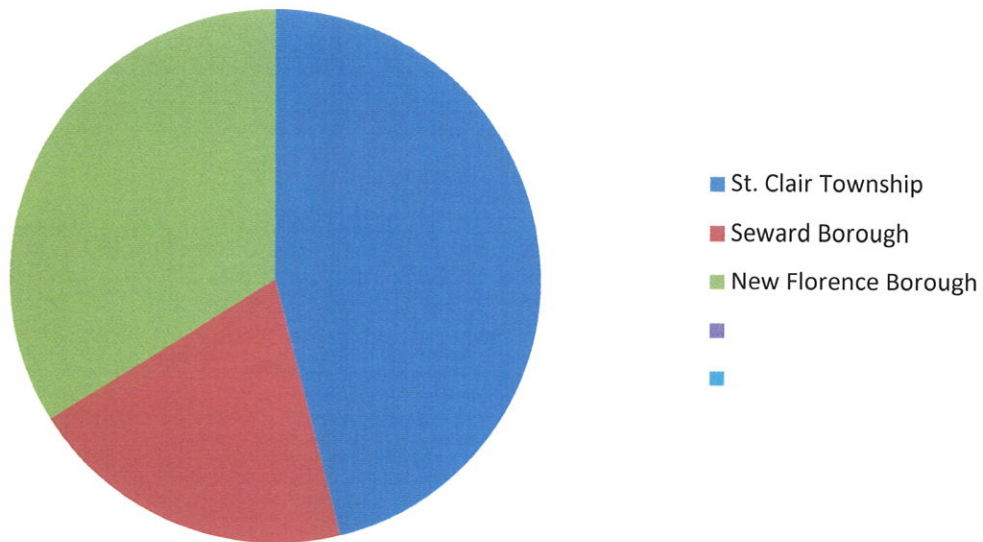

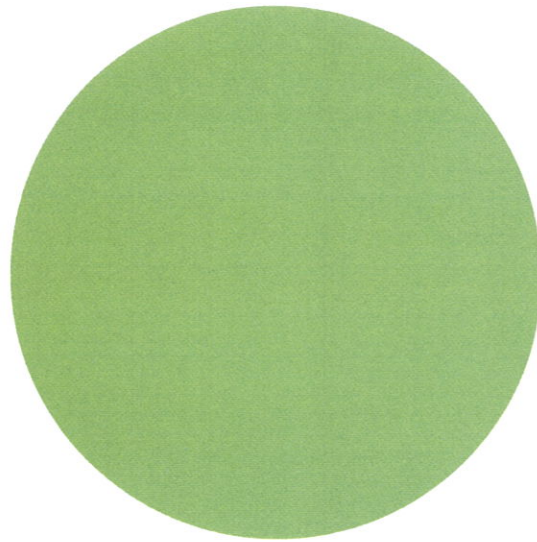
