Police Department Report for November 2023


- 1. Evidence system creation: a new evidentiary system was put in place based upon updated policy. This system allows for checks and balances to avoid and/or detect any wrong-doing in the process, a lesson learned from past mistakes of other departments. This system involves layers of security and a protected, electronic log of all property (evidentiary/other) possessed by this department. With the creation of the new system, an audit of all evidence was taken. In the near future, the process will begin for the destruction of evidence no longer needed. This was a complicated endeavor based on the fact that, in March of 2021, this department assumed control of all evidence from both Seward Borough and New Florence Borough.
- 2. The work continued on the NIBRS (National Incident Based Reporting System) project. An additional free class was attended by myself and Officer Goggin. This class was specific to NIBRS reporting in PA. The class was a virtual class. While on the topic of crime reporting by police departments to the FBI: I am of the belief that most departments are under-reporting their crime for various Perhaps the most common reason is a misunderstanding of the reasons. reporting requirements for the system. To report correctly, one must have a thorough knowledge of the associated system manuals. This data collection is meant to be standardized and uniform, not based on opinion or quirks. If it fails to be uniform, the data that is received by the FBI creates an inaccurate picture regarding crime. This affects available funding from the federal government. One such example lies in the reporting of frauds. There will be more to come on this matter in the future, as it is a work in progress. Each of our communities has received reports of frauds. Historically, these are not reported correctly (if at all) to the FBI.
- 3. Much time is being put into the NIBRS project because:

- a. It is required by PA and the FBI. NIBRS has been required since January 1, 2021 (although enforcement of this requirement has been non-existent for a number of reasons).
- b. Any funding from the PA Commission on Crime and Delinquency can be stopped for non-compliance
- c. The portion of fine money from citations that typically goes to the municipality can be stopped.
- d. It creates an accurate picture of crime within a community which is publicly accessible.
- e. The current theme regarding the funding of projects involves an ability to provide accurate data to allow for data-driven decision making. This sort of decision-making should provide for the most efficient usage of any funding received, based on the problems identified by the data.
- 4. This department must begin "out-sourcing" some of the more detailed or complicated investigations. We are doing this not because we are not capable. We will be doing this because these complicated investigations have taken much time away from patrols, traffic details, community policing, and more. As the saying goes, you can't be 2 places at one time. This determination will be made by the Chief on a case-by-case basis.
- 5. Fraud: probably the most under-reported crime in the country. Did any of you ever have fraudulent activity on a credit card or debit card? In most cases, this is never reported to the police. The bank only sends a new card. Did you ever get a call indicating that you won something but needed to send money to someone or someplace to "release your winnings"? Those are also incidents of fraud. Even if you don't provide them with information or send money (and lose it). Did you ever get a call indicating that a relative was in jail or had a warrant and you needed to purchase gift cards and provide the numbers? That is also a fraud. We need to know about these completed and attempted frauds. understand that we may not be able to arrest anyone for the attempt. We need the reports because these get filed with both the state and federal authorities by us. When they look at the distribution of crimes (including frauds/attempts), they decide how they will allocate their resources and funding to address the problem. This is a simple example of "data-driven" decision making. If we aren't showing the numbers, their opinion is that we don't have a problem. So please, make the report with us.
